We have been informed by Fidelity Funds that with effect from 30 July 2024, the following updates will be made to the underlying funds corresponding to the Investment Choices (each an "**Underlying Fund**" and collectively, the "**Underlying Funds**"). As the unitholders of the Investment Choice(s), the following updates applicable to the Underlying Fund(s) may have implications for your investment.

As part of Fidelity Funds' ongoing commitment to responsible and sustainable investing, Fidelity Funds is updating their approach to Sustainable Investing and environmental, social and governance ("**ESG**") integration, to reflect the evolving sustainable investing landscape and enhance transparency to unitholders.

Fidelity Funds will be introducing ESG portfolio scores to promote environmental and social characteristics of the Underlying Funds. Funds.

The Underlying Funds will aim to have an ESG score greater than that of their investment universe or benchmark.

Furthermore, the current investment process of the Underlying Funds provides that they invest at least 50% of their assets in securities of issuers or companies with favourable ESG characteristics. This limit will no longer be included as part of the investment process of the Underlying Funds.

The current investment process of the Underlying Funds provides that they invest at least 70% of their respective assets in securities of issuers with favourable ESG characteristics.

The Underlying Funds will invest a minimum of 80% in securities with high ESG ratings¹ and up to 20% in issuers with lower ESG ratings including those with low but improving ESG characteristics.

¹ High ESG ratings are defined as issuers rated by Fidelity ESG ratings as a B or above, or in the absence of a rating from Fidelity, an MSCI ESG rating of A or above.

Fidelity Funds will be removing the Underlying Fund's minimum commitment to invest at least 50% of assets in securities with favourable ESG characteristics and the Investment Manager will take into account Sustainability Risks in its investment process. Consequently, the Underlying Fund will no longer be categorised as an Article 8 product under the Sustainable Finance Disclosure Regulation ("SFDR").
