Reference is made to our notice issued on 17 September 2024 ("Letter") in respect of "Changes to the underlying funds corresponding to the following investment choices of abrdn SICAV I ("abrdn SICAV I")", we are writing to provide clarification to section 2 "Renaming of abrdn SICAV I – Select Emerging Markets Bond Fund, abrdn SICAV I – Select Euro High Yield Bond Fund and rename of the following corresponding investment choices" of the Letter.

As mentioned in the Letter, with effect from 30 September 2024 (the "Effective Date"), the term "Select" has been removed from the name of the underlying fund corresponding to the Investment Choice (the "Underlying Fund"), as set out below, to improve consistency across abrdn's SICAVs funds' range

As a result of the name change of the Underlying Fund, this is to clarify that the name of the Investment Choice has also been changed from the Effective Date with details set out in the table below.
