Unless otherwise specified herein, capitalized terms used in this letter shall have the meanings assigned to such terms in the Explanatory Memorandum of Franklin Templeton dated April 2024, as amended from time to time (the "Explanatory Memorandum").

(The "Investment Choice")

We have been informed by Franklin Templeton Investments (Asia) Limited, Hong Kong representative of Franklin Templeton, of the change to the investment management structure of the underlying fund corresponding to the Investment Choice (the "**Underlying Fund**"), effective from 31 March 2025 (the "**Effective Date**"). As the unitholders of the Investment Choice, the following change applicable to the Underlying Fund may have implications for your investment.

Currently, the Management Company of the Underlying Fund (Franklin Templeton International Services S.à r.l.) has delegated the portfolio management of the Underlying Fund to Franklin Templeton Investment Management Limited ("FTIML") as the Investment Manager.

To reflect an internal reorganization of investment personnel responsible for the investment management of the Underlying Fund, it is proposed that Franklin Templeton Investments Corp. ("FTIC") will be appointed as an additional Investment Manager of the Underlying Fund, alongside FTIML to carry out discretionary investment management functions for the Underlying Fund.

FTIML and FTIC are wholly-owned subsidiaries of Franklin Resources, Inc.

Rest assured, the above change will have no impact on the features and the risks applicable to the Underlying Fund, nor the operation and/or manner in which it is being managed. The change sets out in this letter is not expected to materially prejudice the rights or interests of unitholders. The investment team at Franklin Templeton has always managed assets based on a team approach and the Underlying Fund will continue to be managed according to the same principles.

The change sets out in this letter will not give rise to any change in the fee level/cost in managing the Underlying Fund. Any costs and/or expenses arising from the above change will be borne by the Management Company of the Underlying Fund, other than the cost of publishing the letter by Franklin Templeton, which is estimated to be approximately HKD5,000 and which will be charged to the Underlying Fund.

The Explanatory Memorandum and the Product Key Facts Statements of the Underlying Fund will be updated to reflect the above changes in due course. An updated version of the Explanatory Memorandum and the Product Key Facts Statement of the Underlying Fund will be available for download from the Hong Kong representative's website at www.franklintempleton.com.hk4.

You do not have to take any action if you wish to remain invested in Investment Choice regardless of the above change. Otherwise you may wish to consider switching the units of Investment Choice or redirect future regular premiums/contributions (if applicable) to other investment choice(s) through the usual application procedure. No switching fee(s) will be incurred under the current fee structure of your policy.
